INTRODUCER NEEDLE **Instructions for Use**

Indication for Use:

These needles are used for the percutaneous introduction of guidewires.

Device Description:

Introducer Needles are composed of two components: a stainless-steel cannula with over molded hub. The introducer needle provides an access path into the vasculature.

Potential Complications:

- Air embolism
- Bleeding Device dislodgement
- Needle cannula breakage
- Hemothorax
- Infection
- Pneumothorax
- Thrombosis
- Trauma to vessels

Warnings:

- Do not re-sterilize the needle by any method.
- Re-Use may lead to infection or illness/injury.

- Attach syringe to needle hub, if applicable
- Hold skin taut
- Adjust angle of insertion and insert needle tip, bevel of needle up
- Puncture vein;
- Aspirate to assure proper placement

Introduce guidewire per hospital procedure.

Needle Disposal:

The needle should be disposed in accordance with policies and procedures for contaminated sharps disposal.


